**Subject: Accord of Autonomous Status to DRIEMS Polytechnic, Tangi, Cuttack, Odisha-reg.**

Sir/Madam,

This is in reference to the proposal submitted by Skill Development & Technical Education Department, Government of Odisha to grant Autonomous Status to DRIEMS Polytechnic, Tangi, Cuttack, Odisha.

On the basis of the report of the Evaluation Committee under Chairmanship of Vice Chairman State Council of Technical Education & Vocational Training, (SCTE & VT) Odisha, Bhubaneswar and the recommendation of the Expert Committee of AICTE, the competent authority has accorded Autonomous Status to DRIEMS Polytechnic, Tangi, Cuttack-754 022, Odisha affiliated to **Skill Development & Technical Education Department, Government of Odisha** for a period of Five (05) years from the date of issuance of this letter.

Pursuant to the above, the Skill Development & Technical Education Department, Government of Odisha shall issue the necessary orders in this regard in accordance with the **AICTE Guidelines for Grant of Autonomy to Polytechnic Institutes (Amended)-2025**, and as per the details mentioned in the **Annexure**.

DRIEMS Polytechnic, Tangi, Cuttack, Odisha shall strictly abide by the provisions of the AICTE Guidelines for Grant of Autonomy to Polytechnic Institutes (Amended)-2025, AICTE Rules and Regulations issued from time to time for Autonomous Polytechnic Institutes, as well as the Rules and Regulations of the Skill Development & Technical Education Department, Government of Odisha.

The institute shall take special note of the following:

- i. The institute shall constitute the Internal Quality Assurance Cell (IQAC), Examination Cell, and other statutory bodies as mentioned in the Annexure, with due intimation to AICTE.
- ii. The institute shall maintain at least one-third (1/3rd) of the eligible courses accredited by NBA during the autonomous period.
- iii. The institute shall apply to AICTE for extension of autonomous status at least six months prior to the expiry of the autonomy cycle. Failure to apply within the stipulated timeframe may result in withdrawal of autonomous status by AICTE.
